LEADERSHIP FOCUS

I have participated in our Research Leadership Academy through the Office of Vice President for Research. I have also served as the Director of Graduate Studies for two years. Through these leadership opportunities I have now created a Food as Health Alliance as a core institute within the University of Kentucky and serve as the Director. Efforts that involve a health care and agricultural response for better nutrition fall under the umbrella term "Food as Health." An emerging body of research and policy recommendations demonstrates the enormous promise of Food as Health interventions and administrative support across a range of health conditions in improving health, food insecurity, and reducing health care costs. **The Mission of the Food as Health Alliance is to** Increase and sustain the University of Kentucky impact in the interdisciplinary arena of food, agriculture, and health for the Commonwealth. This institute now guides researchers, educators, clinicians, and outreach staff to conduct research to inform policy recommendations for Medicaid and Medicare adults to receive cost-effective benefits related to Social Determinants of Health (SDoH). We have raised \$1,000,000 in external funding to help support these efforts and have been recognized by the White House with our partnerships. Through this new Alliance we have established ourselves as the key technical and evaluation provider to understand how the Centers for Medicare and Medicaid policy regarding Social

Determinant of Health (SDoH) practices can be cost-effective and efficient to reduce health disparities. My leadership focus brings together my research expertise in food insecurity policy but also mentoring of the next generation of leaders. In addition,

LEADERSHIP STYLE

My leadership style is a soft hand touch and creating a culture of respect and opportunity to embrace failure. I have honed this approach over several years in varying degrees and have found with a new generation of students, scholars, and staff there are cultural norms that have shifted, and we need to allow for a greater emphasis on learning and growth rather than a particular outcome. I believe a leader highlights the strengths of team members while also creating a culture of utilizing our mistakes as key opportunities for growth. Over the past 12-years at the University of Kentucky I have been able to build bridges with departments across campus to facilitate an innovative approach to research while also growing the next generation of leaders in our state.

RESEARCH FOCUS

My research goals have focused on one central theme – examine and inform policy approaches to reduce food insecurity and interrelated social factors to improve health outcomes and subsequent healthcare costs. My research enterprise is built around examining the distal and proximal determinants to food insecurity among health disparate populations. Through primary data collection and secondary data analyses I have established an expertise with measurement of the food environment and food insecurity along with development of programs to address these ever-pressing issues. My accomplishments to date, include the ability to secure funding through extramural competitive grants but also through key collaborations with experts across universities. As Director of Graduate Studies, I was able to elevate the quality and quantity of admissions, while transitioning our forms, website, and reporting. I have been enthused by the high level of graduate student mentoring that continues to take place and anticipate additional student-led publications resulting from this mentorship. Mentoring several DHN assistant professors in grant writing and have led to meaningful collaborations on several USDA and NIH grant submissions. I have had graduate students publish first author papers and contribute to journal article submission and publication. I have mentored high school students, with one being awarded a first author publication and an award for best student paper from Preventing Chronic Disease journal. My publications have included assistant professors within the DHN and professors from various other universities across the nation.
